## MINUTES OF THE DAVIESS COUNTY PUBLIC LIBRARY DISTRICT BOARD OF TRUSTEES MONTHLY MEETING

July 17, 2019

The meeting was called to order by President Michelle Drake at 5:01 p.m.

Michelle Drake called for the approval of the minutes of the June meeting. Hearing no comments or corrections, Jim Kuhlman made a motion to approve the June minutes as presented. Rodney Ellis seconded and the motion carried unanimously.

Rodney Ellis presented the Treasurer's Report. He went over the June, 2019 financial report including the receipts and expenditures for the month. Hearing no comments or corrections, Jim Kuhlman made a motion to approve the financial report and expenditures as presented. Susan Gesser seconded and the motion carried unanimously.

Erin Waller was asked to present the Director's Report. Mrs. Waller reported on programs being held in July and upcoming events. Mrs. Waller discussed the following:

- The Library is still experiencing Malware issues from April. It is a continuing and bigger issue than originally thought. The virus is super aggressive and is somehow hiding on the servers and keep popping back up. The Library has talked to several security experts regarding this issue. We had a visit from one computer expert in Bowling Green and he helped to make some changes to the firewall. We also talked to a security consultant in Texas that will be helpful with getting solutions to this issue. There was no data breach and no data was lost.
- Summer Reading is going well with over 2,000 individuals registered and everyone is reading and logging points.
- On June 26 we had a Toy Story Children's Program which had attendance between 400-500 people and after the program there was a Ribbon Cutting with the Kiwanis in the Reading Garden for the musical instruments.

Michelle Drake called for Old Business – Board Member Nominations. Erin Waller discussed with the Board that Michelle Drake's first term expires September 13, 2019. Mrs. Drake has expressed interest in being on the board for a second term. The Board must nominate another person in addition to Mrs. Drake for the board seat. After discussion, Susan Gesser made a motion to nominate Michelle Drake and Joanna Shake for the open board seat. Rodney Ellis seconded and the motion carried unanimously. Mrs. Drake will provide Debbie Young the information needed to submit Ms. Shake's name. The names will be submitted to KDLA who will then submit that information to County Judge Executive Al Mattingly who will choose one of the two candidates to fill the board seat.
