The meeting was called to order by President Michelle Drake at 5:13 p.m.

- Mrs. Waller reported that the Library has rolled out the Fine Free policy and its going well.
- Summer Reading is getting ready to start with the Kick-Off Party on May 31.

- The Collection Development Department is working on moving some of physical materials to better serve the patrons. So far the CD's and DVD's have been moved from the Second Floor to the First Floor.
- This Saturday, May 20 the Friends of the Library are hosting a Fund Raising Trivia Night event. There is a \$50 fee per team.
- Mrs. Waller updated the Board that in September, Michelle Drake's term as a Board Member will expire. She has served two terms so she cannot serve another term. We need to have at least two names to submit for her open seat. We will also need to appoint new officers and will need someone to serve as the Board President.
- Mrs. Waller also noted that she has a conflict with the July meeting and asked the Board to think
  about if they wanted to move the meeting or move forward without her attendance. This will
  be on the June agenda.
