- The Library is having a lot of success with programs such as the Jigsaw Puzzle Competition, Handmade Crafts Fair and the Civil War Living History Event at Yellow Creek Park and there are many more great events coming up in June and July.
- The number of patrons coming into the Library has increased along with event attendance and circulation statistics also being higher.
- The Library uses the Hoopla digital services and they have added a lot of extra items for the collection, including over 1,500 hours of Hallmark movies.
- We are still in the process of shifting the physical collection to better accommodate the patrons.
